#### **DIRECTIONS TO SHOW GROUNDS**

Long Island Expressway, Route 495 East, to Exit 70. Follow sign to Route 27 East (Montauk Hwy). Follow Route 27 East THROUGH the Village of Bridgehampton to the next traffic light, turn right onto Sagg Main Street. Continue on Sagg Main St. to flag pole; bear left at the cemetery then turn immediate left onto Gibson Lane then turn left on Daniels Lane.

**Membership Statement** 

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadlir.e; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

## **RULES AND REGULATIONS FOR HORSE SHOW**

- 1. Every class offered herein which is covered by the specifications of the current United States Equestrian Federation Rule Book will be conducted and judged in accordance there with.
- 2. It is compulsory for all persons at Federation licensed hunter, jumper, or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag.
- 3. Riders may choose to wear protective vests in lieu of or in addition to a show jacket. All other attire rules still apply.
- 4. MEMBER LIPHA. All points won at this show will count toward the annual LIPHA Year End Awards. In order to be eligible for an award in any LIPHA section, a horse, pony or rider must have shown in that section in at least four member shows and be an active member.
- 5. The following requirements and recommendations have been drafted by the management of this horse show in consultation with our show veterinarian and the NY State Division of Animal Industry: All horses being brought onto the grounds must be accompanied by a Statement of Health signed by a licensed veterinarian showing vaccination against EHV-4/1 with the most recent booster being within 120 days of the show.
- 6. ENTRIES CLOSE AT 6PM THE MONDAY PRIOR TO THE SHOW. Post Entries may be accepted at a cost of \$40.
- 7. NO BACK NUMBER WILL BE GIVEN OUT WITHOUT AN OPEN CHECK, PROOF OF A NEGATIVE COGGINS DATED WITHIN 6 MONTHS AND ENTRY BLANK SIGNED BY OWNER, EXHIBITOR OR HIS AUTHORIZED AGENT AND TRAINER.
- 8. A processing fee of \$50 or 10% of the check will be made for all non-negotiable returned checks.
- 9. All exhibitors in the Junior, Pony, and Children's (Pony) Hunter Section must present their United States Equestrian Federation measurement cards at the Show Office before numbers may be picked up.
- 10. All exhibitors in the Amateur Sections must present their amateur USEF certification at the Show Office before numbers may be picked up. To speed processing you may send a photocopy of your card along with your entry blank.
- 11. If necessary to meet time schedule requirements and preserve a balance with entries in other divisions, show management reserves the right to limit the number of entries accepted in each division, (first come, first served basis). Also reserved is the right to move the location of classes and adjust the time schedule and add a dotted line on the course if, in the opinion of management, circumstances dictate such changes.
- 12. Classes with insufficient entries may be canceled or combined.
- 13. Should any question or dispute arise that is not provided for in the rules, refer to the Show Management, WHOSE DECISION SHALL BE FINAL.
- 14. Trophy or money and eight ribbons in all classes. Prize monies issued are applied to entries.
- 15. In all Hunter Classes, fences shall simulate those found in the hunting field such as rails, gates, aiken, oxer, coop, roll-top, etc.
- 16 .HUNTER UNDER SADDLE CLASSES. To be shown at a walk, trot and canter, both ways of the ring. Light contact with horses/ ponies mouth is required. Horses may be asked to hand gallop collectively one way of the ring at the judge's discretion, but never more than eight at one time. Children's Hunters will not be asked to hand gallop.

- 17. HUNTER CHAMPIONSHIP AND RESERVE. Champion and reserve titles shall be awarded to two of the four horses/ponies which have acquired the most points performing over fences. In addition, only these four horses will receive full points for the Under Saddle Class, and half points won in the model.
- 18. EQUITATION CHAMPIONSHIP AND RESERVE. The champion and reserve titles will be awarded to the rider acquiring the most points in each Equitation Section, except Open. In the event of equality of points for Championship, the rider with the most points over fences will be awarded the Championship. In the case of equal points being accrued in classes over fences, the rider with the highest number of points in the first class over fences will be awarded the championship.
- 19. A rotating jumping order will be established for all classes over fences. Post entries in jumping classes which are received after the jumping order is established will automatically go first in the order in each class. Riders who have conflicts due to classes in more than one ring must see the Gate person in charge of the jumping order so that necessary adjustments can be made. Trainer conflicts will not be honored.
- 20. Once a horse is entered and accepted by the show, it may not be withdrawn from competition in the show without permission of management. Exhibitors shall be responsible for entry fees of all horses entered by them or their agents even though the payment of these fees is not submitted along with entry blank. In any event, and regardless of reason, horses which are not shown in classes in which they are entered forfeit their fees, except if a horse is injured or becomes ill prior to the class or classes entered. The entry fee in this case will be refunded or dropped less an office charge of \$35.00 upon receipt of a certificate signed by a licensed veterinarian and presented NO LATER THAN ONE HOUR BEFORE SCHEDULED CLASS. Once the show has started, only certificates from the OFFICIAL SHOW VETERINARIAN will be accepted.
- 21. ALL DOGS MUST BE KEPT LEASHED AT ALL TIMES WHILE ON THE SHOW GROUNDS.
- 22. The committee reserves the right to add or vary the list of judges if deemed necessary.
- 23. THE SAGAPONACK HORSE SHOW & TOPPING RIDING CLUB INC, their Officials and employees will not be responsible for any accident or loss which may occur to any exhibitor, spectator, guest, rider, groom attendant, or other employee, animal or equipment at this show.
- 24. ALL HUNTER CLASSES WILL BE JUDGED ON PERFORMANCE and SOUNDNESS.
- 25. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
- 26. No mounted rider unless medic is on grounds. No mounted rider without back number and ASTM approved helmet. And or SEI approved helmet.
- 27. In Compliance with GR844 in the USEF rule book. Please be sure your horse's vaccinations are up to date. For more information please refer to the USEF rule book.
- 28. In accordance with HU101-HU104, J100, and EQ103. Horses competing in classes that require a USHJA Horse Registration will be required to be microchipped to receive points. All horses and ponies are required to have a microchip or they cannot show.
- 29. Please refer to our 2021 COVID-19 Sagaponack Horse Show Protocols and Waiver
- 30. Stabling is available for emergency circumstances in a temporary stabling tent. Stalls are 10x10' with doors and earthen floors.
- 31. Please bring or be able to show proof of your membership cards and measurement cards.
- 32. Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org

#### **LIPHA SPECIFICATIONS**

Rider Eligibility on Ponies: In accordance with USEF rules, adults may show ponies in classes that are not restricted to junior riders, however that pony may not be shown in any junior exhibitor class at the same show. See USEF rules for Zone and National divisions.

CLASS SPECIFICATIONS The following classes will follow the USEF Rule Book: The following sections will follow the USHJA Zone Specifications: Children's Hunter Pony, Children's Hunter Horse, Adult Amateur Hunter, Children's Jumper, Adult Amateur Jumper.

In the event of a discrepancy between LIPHA specs and USHJA specs, the USHJA specs are to be used.

LIPHA BEGINNER EQUITATION: Open to riders who have not reached their 18th birthday and who have not showed in any class where jumping a course of jumps. Once a rider competes in the mini-short stirrup or above they are no longer eligible for beginner equitation. (Classes 15, 17, 18, 19 is eligible at Sagg I and Sagg II)

LIPHA SHORT STIRRUP: A rider who enters and shows in the Short Stirrup Division (Equitation or Hunter) shall not be eligible to enter any other section or division at that show. Riders must be age 12 or under as of December 1st of the current show year. In order to split the section 8 are needed, at least 3 in each section. Section to be split by age. 10 and under and 11-12. Permissible test for the Short Stirrup Equitation is USEF Hunter Seat Equitation Test #1. (Halt and/or back). Courses for all short stirrup classes must consist of at least six (6) cross rails not to exceed 18". In the Short Stirrup Hunter Section, courses must contain 1 change of direction

CHILDRENS & ADULT AMATEUR HUNTERS: To be run according to Zone 2 specifications

LIPHA CHILDRENS HUNTER HORSE: Rider 14 & under & 15 to 17

LIPHA ADULT AMATEUR HUNTER: Combined Award Younger & Older divisions. May be split at shows if entries warrant at managements discretion.

LIPHA CHILDRENS HUNTER PONIES: Small/Medium & Large

LIPHA LOW CHILDRENS/ADULT HUNTERS: Open to juniors & adults. Two sections must be offered: Ponies and Horses. If there are less than 3 entries in either the Pony section or the Horse section, both sections must be combined. Ponies to jump 2' and horses to jump 2'6". Riders may not cross enter into the Children's or Adult Amateur Hunter division or any class/section where fences exceed 2'9" (Exception 3'0" Equitation). If entries warrant, the division may be split for year-end awards.

LIPHALOW HUNTERS: No restrictions as to horse/pony or rider, no restrictions as to cross entering. Fences 2'6". At the discretion of Show Management a Handy Hunter Class may be offered in this division. USEF specs apply.

LIPHALOW CHILDRENS/ADULT EQUITATION: Open to junior & adult exhibitors. Fences 2'. Riders may not cross enter into the Children's or Adult Amateur Hunter division. Riders may not cross enter into any other equitation class or hunter class where fences exceed 2'6".

LIPHA ROSS REISNER MINI MEDAL: Division makes up a combination of Medal, Maclay, and PHA equitation classes that are a modified version of the courses used in the National Medal Classes (3'6" and 3' classes). Fences at 3'0". LIPHA HIGH ADULT MEDAL: Division makes up combination of Medal, Maclay and PHA equitation classes that are a modified version of the courses used in the National Medal Classes (3'6" and 3' classes). Fences at 3'0". May be combined with Ross Reisner Mini Medal if there are fewer than 3 entries at horseshow. For LIPHA year-end awards, this class will be combined with Ross Reisner Mini Medal unless there are at least three qualified adult riders. LIPHA JUNIOR MEDAL: To be run in accordance with current PHA equitation rules. Fences at 3'6".

Open only to senior amateur members of the USEF or Equine Canada who have reached their 18th birthday as of December 1st of the current competition year in accordance with GR101. Previous winners of the THIS NHS Adult Equitation Championship 18-24 who have reached the age of 25 or over may compete in any THIS NHS Medal classes as well as the THIS NHS Adult Equitation Championship 25 and Over. Previous winners of the THIS NHS Equitation Championship 25 and Over are ineligible to compete in any THIS NHS Adult Medal or the Finals.

#### 323 ARIAT NATIONAL ADULTMEDAL

ENTRY FEE \$50 Fences 3'

Open to all Amateur members of USEF and Equine Canada who are eligible to compete in the Adult Amateur Hunter Section at this show (based on USHJAZone specifications for the shows location.). Additionally, a rider may not show in any jumper class set at 1.20m or higher at the same show. To be shown over a minimum of eight fences 2'9" to 3' in height, spread not to exceed fence height.
