



Sagaponack Horse Show COVID-19 Protocols for 2021

No post entries will be accepted. There will be no exceptions.

Competition Staff Guidelines

We will require temperature monitoring for volunteers, officials, and competition staff prior to entering the competition grounds. Anyone with a temperature of 99.5° F (37.5° C) or higher may not enter the facility.

Personal Protective Equipment (PPE)

All employees & competitors on the property will need to wear a face mask at all times when not mounted if not vaccinated. Vaccinated individuals can show proof of vaccination or an excelsior pass at entry. We will provide all staff with necessary protective gear as required by state and local regulations. We will have additional PPE on site if necessary. Unvaccinated individuals continue to be responsible for wearing masks, in accordance with federal CDC [guidance](#). Consistent with the State's [implementation](#) of the recent CDC guidance, masks are still required for unvaccinated individuals.

Competitor and Participant Guidelines

- 1) There will be no spectators allowed on the premises.
- 2) “Show and go theory.” Exhibitors are to arrive in time to warm up and show on time. Exhibitors are asked to leave the premises as soon as their classes are completed.
- 3) Each competitor may have: 1 Trainer, 1 Groom, and if a minor: 2 parents or guardians. Please respect this rule. There will be a monitor at the parking entrance/exit.
- 4) Each person who comes to the premises must have all 3 waivers completed:
 - A) USEF Entry Agreement
 - B) USEF Waiver and Release
 - C) Sagaponack Horse Show Waiver
 - Anyone who does not agree to sign the waiver or refuses to follow the event regulations and protocols will be denied entry or asked to leave immediately.
- 5) Each participant agrees they have reviewed the USEF COVID-19 Protocols and the Sagaponack Horse Show COVID-19 Protocols.
- 6) Every unvaccinated person on the premises must be masked at all times when not mounted.
- 7) Parking: All exhibitors are to enter from the 58 Daniels Lane entrance and use the field parking lot. Trailer and horse parking are available in the field lots off Sagg Main.
- 8) Participants are required to self-monitor their temperature daily prior to entering the competition grounds. Anyone with a temperature of 99.5° F (37.5° C) or higher may not enter the facility. Anyone who exhibits COVID-19 symptoms, has tested positive for COVID-19 within last two weeks, or has been in contact with someone who has tested positive for COVID-19 within the last two weeks, cannot enter the competition grounds. If anyone violates these requirements, management has the authority to remove the person from the grounds.
- 9) Signage will be posted throughout the property displaying applicable CDC, federal, state, and local governmental safety advisories regarding COVID-19.
- 10) Current NYS Social distancing requirements will be enforced throughout the grounds.
- 11) Any violation of this protocol is grounds for asking the signer to depart the premises immediately.
- 12) These rules are subject to change.

Sagaponack Horse Show COVID-19 Entrance Affidavit and Waiver

By signing this form, I hereby agree to the 2021 COVID-19 Policy and Rules for the Topping Riding Club, Inc. and Sagaponack Horse Shows. I also certify that I am following the protocols of the USEF COVID-19 Action Plan, specifically the mandatory requirements for Participants. In doing so:

- I have self-monitored my temperature daily for the last two weeks prior to entering the competition grounds and have maintained a temperature below 99.5° F (37.5° C).
- I have not exhibited COVID-19 symptoms as described by the CDC in the last two weeks.
- I have not exhibited Covid-19 symptoms, tested positive for Covid-19 in the past ten days, or been exposed to or has been in close contact with someone who has Covid-19 symptoms or has tested positive for Covid-19 within the last 7 or 10 days, or has tested positive outside of the past 10 days, but is still symptomatic cannot enter or have access to the facility.
- I understand and agree that it is my responsibility to wear a facemask or face covering when in a public setting if I am not vaccinated.
- I will self-monitor my own temperature every morning prior to leaving for the show grounds.
- If I should begin to experience any symptoms of COVID-19 or exhibit a temperature of 99.5°F (37.5°C) or above after my initial entrance onto the show grounds, I will immediately notify Sagaponack Horse Show management and seek medical help.
- If I should begin to experience any symptoms of COVID-19 or exhibit a temperature of 99.5°F (37.5°C) or above within 14 days of leaving the competition, I will notify Sagaponack Horse Show management and immediately seek medical help.
- If I am diagnosed with COVID-19 after arriving at a competition or within 14 days of leaving the competition, I will notify Sagaponack Horse Show management so specific steps can be made to quarantine others that may have been affected prior to that diagnosis.
- I understand that I am required to provide a valid cell phone number and email address so I will receive all notifications from the competition.

EQUINE ACTIVITY LIABILITY ACT WARNING: CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK.

IN RETURN FOR THE USE OF THE PROPERTY, FACILITIES, HORSES, AND SERVICES OF THE TOPPING RIDING CLUB, INC (TRC AND SHS) and SAGAPONACK HORSE SHOW (SHS) BY THE UNDERSIGNED AND/OR ANY CHILDREN NAMED BELOW, THE UNDERSIGNED HEREBY EXPRESSLY AGREES FOR HIM OR HERSELF AND ON BEHALF OF HIS OR HER HEIRS, ASSIGNS AND LEGAL REPRESENTATIVES TO THE FOLLOWING:

A. **ACKNOWLEDGMENT OF RISK:** The undersigned, willingly, and voluntarily acknowledges the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any equestrian activity involves risks and dangers including, with- out limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of management; and other undefined, not readily foreseeable and presently unknown risks and dangers (“Risks”).

B. **ASSUMPTION OF RISK:** THE UNDERSIGNED EXPRESSLY ASSUMES RESPONSIBILITY FOR ALL RISKS INVOLVED IN OR ARISING FROM HORSEBACK RIDING BY THE UNDERSIGNED AND ANY CHILDREN NAMED BELOW(COLLECTIVELY, THE “RIDER”), including but not limited to risks arising from the propensity of horses to behave in a dangerous way and the inability to predict a horses reaction to sound, movements, objects, vehicles, persons or animals, and hazards of surface or subsurface conditions whether natural or man-made, which may result in injury or death to the Rider.

C. The undersigned understands and agrees that horses and equipment provided, leased or sold by TRC AND SHS to the Rider are provided, leased, or sold without warranty that they are fit to use for any purpose or for a specific purpose, that such horses and equipment are leased or sold on an as is basis and that no warranty or representation is made as to the adequacy of training provided by TRC AND SHS personnel.

D. **WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY:** The undersigned does and shall waive all rights against, and does and shall forever discharge and release from liability, TRC AND SHS, its directors, officers, employees and agents, and the owners, lessees, lessors or licensees of all premises on which the Rider is present at any time in connection with his or her activities at or with TRC AND SHS and any successors assigns, heirs or personal representatives of any of the foregoing (collectively the Released Parties) for all claims which the undersigned or the Rider may now or hereafter have for any injury directly or indirectly related to horseback riding with TRC AND SHS or any use of or presence upon TRC AND SHS property or facilities or any other activity conducted by TRC AND SHS or its designers, including but not limited to physical injury or death economic or pecuniary loss cost or expense mental or emotional injury, or property damage.

INITIAL HERE:

The undersigned releases, waives and covenants not to sue, and further agrees to indemnify, defend and hold harmless TRC AND SHS, its directors, officers, employees and agents, contractors, volunteers, and the owners, lessees, lessors or licensees of all premises on which the Rider is present at any time in connection with his or her activities at or with TRC AND SHS and any successors assigns, heirs or personal representatives of any of the foregoing (collectively the Released Parties) with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature (“**Liability**”) which may arise out of, result from, or relate in any way to the undersigned’s participation at TRC AND SHS including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. To the extent permitted by applicable laws, in connection with his her activities at with or conducted by TRC AND SHS (or any of its designees or his or her use of, or presence upon TRC AND SHS property or facilities the undersigned is and shall be responsible and liable for all injuries including but not limited to physical injury or death, economic or pecuniary loss cost or expense mental or emotional injury or property damage in each case arising from related to based upon or attributable to the acts omissions of the undersigned or the Rider.

The undersigned agrees that any dispute concerning this document or arising from the activities of the undersigned or the Rider may only be pursued in the court of the State of New York and the venue for any such dispute shall be solely in the County of Suffolk.

If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and

Sagaponack Horse Show 532, 1094 ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual repre- sentations pursuant to this Agreement (the "**Agreement**"):

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, with- out limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or specta- tors; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("**Risks**").

I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

UNITED STATES EQUESTRIAN FEDERATION, INC. ENTRY AGREEMENT

I have read the United States Equestrian Federation, Inc (the "Federation") Entry Agreement (GR906.4) as printed in the Prize List for this competition and agree to all of it's provisions. I understand and agree that by entering this Competition, I am subject to Federation Rules, the Prize List, and local rules of the competition. I agree to waive the right to the use of my photos at the competition, and agree that any actions against the Federation must be brought in New York State. Federation Release, Assumption of Risk Waiver and Indemnification. This document waives important legal rights.

I AGREE that the "Federation" and "Competition" as used herein includes the Licensee and Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, volunteers and Federation affiliates.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. ("Harm").

I AGREE to hold harmless and release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read the Federation Rules about protective equipment, including GR801 and, if applicable, EV114, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form.
